



## PROJECT OF DOMINIKA HEJDUKOVA AND NADĚJE

### A TABLE FOR ONE

Project helping a homeless people by offering a hot meal for free, several times a week by participated restaurants.

Participated restaurant gives one hot meal to the one participated homeless person to the project several times a week.

The owner of the participated restaurant decides about a number of days and time of homeless client's visits. He can choose if the client will eat in the restaurant or he will get his meal to go.

Non-profit organization NADĚJE chooses clients for participating and is a professional guarantor of the project too. We have partner - cooperating community Sant' Egidio in Slovakia for running project and tipping homeless clients for participating in Topolčany. Chosen clients must accept basic project rules (to arrive on agreed days and in time, in an acceptable state, not tipsy, etc.).

Author and coordinator of the project A Table for one is Dominika Hejduková.

The restaurant owner can join the project with filling out a questionnaire available at the official project's website [www.stulprojednoho.cz/zapojtese](http://www.stulprojednoho.cz/zapojtese) or contacting the coordinator. First meeting of the restaurant owner with his client happens in company of a social worker from the NADĚJE, giving the project member card to our clients too. We can monitorate client's attendance by this card every month and evaluate the benefits of his participating.

In present we have twelve participated restaurants in Prague and Slovakia and we have helped to eighteen homeless people by the participating to the project A Table for one so far.

## THE RULES (RECOMMENDATION) FOR THE RESTAURANT OWNERS

1. Accept the client (a homeless person), who can prove his membership by the project member card (a voucher) from the NADĚJE organization only. This voucher is valid for one month. In case of any changes NADĚJE can cancel the client's membership anytime
2. All of the potential candidate is possible to direct to the NADĚJE organization.
3. There is one voucher for one chosen client to get one hot meal a day only.
4. In case of non-acceptable manners of the client (forcing more food, disturbing of restaurant running, etc.) refuse the client and inform the project coordinator please.
5. If the client can eat his meal inside the restaurant, it is possible on agreed days and time only. Clients are informed about their obligation to leave the restaurant immediately after finishing their meal. Otherwise contact the coordinator please.
6. If the client gets his meal to go, do not accept him to stay around and do not let to eat his meal nearly the restaurant area please.
7. Clients are informed about their obligation to leave the restaurant immediately after getting their meal to go. Otherwise contact the coordinator please.
8. Owner of the participated restaurant is competent to refuse to give a meal to the client of the project anytime. (Members of the project proving their participating with a project voucher). About this decision inform the coordinator please.
9. Owner of the participated restaurant is not obligated to give a meal for free to the participated client in case of his neglected appearance. Is possible to offer him his meal for free to go. Inform the coordinator about this situation please.
10. Coordinator of the project A Table for one will inform the restaurant staff about a new client's name. Inform the coordinator about client's attendance please.
11. Clients of the project are informed by social workers of NADĚJE about their obligation to notify if they will not come to the restaurant. In case they do not accept this conditions, they can be replaced by another participated client.
